Greg:

I would like for you to consider including my bird recordings in **(the multi media option of) the Peck<sup>™</sup> bird information manager**, (the "Work") published by **Eduneer<sup>®</sup>** ("Eduneer"). The purpose of this letter agreement, whose most recent revision is available at [www.eduneer.com/peck/peck\\_recording\\_agreement.pdf](http://www.eduneer.com/peck/peck_recording_agreement.pdf), is to grant my prior written permission to

- use all or some of my recordings, copies and/or descriptions of which are attached to this letter as Exhibit A (my "Recordings"), which may change from time to time, and
- publish all or some of them as part of the Work

and to define

- my contact information, and
- my choice of the acknowledgement/credit option for my Recordings.

Should I submit subsequent Recordings for inclusion in the Work, such subsequent submissions shall constitute amendments to Exhibit A, and shall be subject to all provisions of this agreement upon acknowledgment by Eduneer in the form of written or email communication.

As further definition, the Work consists of two components:

- 1) The Peck<sup>™</sup> bird information manager application is a no-charge application that integrates several sources of bird reference information, but not photographs or recordings. The Peck<sup>™</sup> application is relatively small, consisting of executable and database files, and is available via Internet download.
- 2) The Peck<sup>™</sup> bird information manager multimedia option is a low-priced compilation of audio and image files for storage on a memory expansion card (e.g., a Secure Digital) and is presented by the Peck<sup>™</sup> bird information manager application. The Peck<sup>™</sup> bird information manager multimedia option may be distributed on CD (Compact Disk), SD (Secure Digital) card, PDA (Personal Digital Assistant) system, or by download.

By signing below, I acknowledge that I am at least 21 years of age and I grant to Eduneer the non-exclusive right and license to use, display, reproduce, publish, transmit, and distribute my Recordings in the Work in all languages throughout the world. The grant and license shall also apply to any reprintings, new or revised editions, or derivative works of the Work in any media or formats, whether now or hereafter known, including without limitation other kinds electronic media (such as on-line systems, CD-ROM applications, and multimedia products).

My signature below also grants to Eduneer permission to use my name in the Work should Eduneer determine to do so. I understand, however, that the inclusion of recordings in the Work is determined monthly from submissions of recordings in a competitive setting. Therefore, nothing in this letter agreement implies any guarantee of inclusion in the Work, and this letter is meant to grant permission to use the Recordings subject to the terms contained herein only if Eduneer selects all or some of the Recordings for inclusion in the Work.

If some or all of the Recordings are selected for inclusion in the Work, I will be paid royalties by Eduneer according to the following schedule:

where the “total # of recordings included in Work” does not include public domain recordings and where the “Update distribution” refers to the update option available to only those who have received a new distribution. If a customer purchases the low resolution version of the Work and later updates to the high resolution version of the Work, the royalties associated with that update will be as if the customer had purchased a second new distribution of the low resolution version of the Work. Payment owed, if any, will be mailed to me within thirty days following the end of each calendar quarter for the amount of my royalty balance if it is at least \$20. If my royalty balance is less than \$20, the balance will be carried forward to subsequent quarters until it reaches at least \$20.

In the event that I decide to withdraw my Recordings from the Work, or from consideration for the Work, as applicable, I must provide written notice (“Notice”) to Eduneer. Eduneer will confirm receipt of Notice in the form of written or email communication addressed to you at the contact information that you provide below. Upon written confirmation by Eduneer, my Recordings will be withdrawn from the Work as of the next update of the Work, but in no event shall Eduneer be required to withdraw my Recordings from the Work in less than thirty days from receipt of Notice. Within thirty days following the quarter in which I withdraw my Recordings, Eduneer will pay royalties then owing if the amount is at least \$20.

**BY SIGNING BELOW I REPRESENT AND WARRANT THAT (I) I AM THE SOLE OWNER OF ALL COPYRIGHT, TRADEMARK, AND OTHER INTELLECTUAL PROPERTY AND PROPRIETARY RIGHTS IN AND TO MY RECORDINGS, (II) THE UNDERSIGNED'S OR EDUNEER'S PUBLICATION OF MY RECORDINGS AS AUTHORIZED HEREIN WILL NOT VIOLATE OR INFRINGE ANY COPYRIGHT, TRADEMARK, OR OTHER INTELLECTUAL PROPERTY OR PROPRIETARY RIGHT OF ANY PERSON OR ENTITY, AND (III) I AM NOT A PARTY TO AND MY RECORDINGS ARE NOT SUBJECT TO ANY CONTRACT OR ARRANGEMENT WHICH WOULD CONFLICT WITH MY PERMISSION HEREIN. I ALSO AGREE TO INDEMNIFY THE UNDERSIGNED AND EDUNEER FROM ANY COSTS, DAMAGES, EXPENSES AND CLAIMS OF ANY TYPES ARISING FROM A BREACH OF THE REPRESENTATIONS AND WARRANTIES MADE BY ME IN THIS LETTER AGREEMENT.**

This letter agreement shall be governed by and construed in accordance with the laws of the Commonwealth of Virginia, excluding its principles of conflict of laws and may not be amended except as otherwise herein provided or in a written document signed by you and the undersigned. Any cause of action arising under this letter agreement shall be deemed to have arisen in Virginia, and the exclusive venue for any matters arising out of this letter agreement or the breach thereof shall be the Circuit Court for the City of Lynchburg or the Federal District Court for the Western District of Virginia, Lynchburg Division. This letter agreement shall be binding upon and inure to the benefit of the successors and assigns of the parties hereto. In the event that any one or more of the provisions of this letter agreement is held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provision hereof and this letter agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained herein.
